Single Buck: No starting cut allowed—16" log
Obstacle Pole: Caulked footwear
Stock Power Saw: Chaps required
Hot Saw: Chaps required

⚙ Contestants will use only Stihl MS 660 (6.6 Cubic Inch with 28 inch sprocket tip bar and 8 tooth sprocket on saw) 91 drive link chain 3/8 pitch .050 gauge. Each contestant must furnish their own chain **and chaps**. Contestants will bore through the log from 4-inch mark to 4-inch mark on opposite side, and then completely sever a 24-inch larch log.
